Amendment No. 27 to the Township of Southgate Official Plan

Index

Part A - The Preamble

The Preamble provides an explanation of the proposed amendment including the purpose, location, and background information, but does not form part of this amendment.

Part B - The Amendment

The Amendment describes the changes and/or modifications to the Township of Southgate Official Plan which constitutes Official Plan Amendment Number 27.

Part C - The Appendices

The appendices attached hereto do not constitute part of this amendment. These appendices contain background data, planning considerations and public involvement associated with this amendment.

Part A - The Preamble

Purpose

The purpose of this Amendment is to add a section to the "General Development Policies" of the Official Plan, section 7.11, to designate the entire Township as a Community Improvement Area and allow the Township to adopt a Community Improvement Plan for the purpose of providing, grants and incentives to foster rehabilitation and redevelopment of properties within the Township.

Location

The amendment would apply to all areas of the Township.

Basis

Section 28 of the Planning Act. Allows municipalities to designate areas as Community Improvement Areas and adopted Community Improvement Plans for the purposes of providing incentives to foster rehabilitation and redevelopment of properties. In order for a Community Improvement Plan to be adopted and approved it must be permitted and recognized within a municipality's Official Plan.

Other Approvals

Following the approval of this Official Plan Amendment by the County of Grey a by-law shall be passed under section 28(2) of the Planning Act that will designate the entire Township as a Community Improvement Area.

Part B – The Amendment

All of this part of the document entitled **Part B – The Amendment**, consisting of the following text constitutes Amendment No.27 to the Township of Southgate Official Plan.

Details of the Amendment

The Township of Southgate Official Plan is hereby amended as follows:

- 1. That the following subsection is added to the Official Plan:
- **"7.11 COMMUNITY IMPROVEMENT PLANS**
- 7.11.1 The Planning Act provides for the opportunity to plan for, coordinate and facilitate development, redevelopment, construction, rehabilitation and reconstruction, resulting in the physical improvement to areas of the Township.

The policies of this section of the plan are intended to provide access to various cost sharing programs, tax incentive programs and grants that are outlined in a Community Improvement Plan.

The Township shall identify and designate by by-law, a Community Improvement Plan Area and develop a Community Improvement Plan for that area. The by-law may designate the entire Township of Southgate if that is Council's desire.

The Community Improvement Plan shall provide and identify the following:

- 1. The goals and objectives of the Community Improvement Plan
- 2. Financial Incentive Programs
- 3. Eligibility requirements and program details for incentive programs
- 4. An application and review process
- 5. Payment and refusal process
- 6. Monitoring and evaluation criteria for the Community Improvement Plan
- 7. An Implementation process including outlining submission requirements including but not limited to elements such as, cost estimates, receipts, design drawings, signage and built form criteria."

Implementation and Interpretation

Subsequent to the adoption of this Amendment, Council will pass a by-law designating the an area of the Township as a Community Improvement Plan Area.
