Background:

Municipal Act, 2001 s. 290(1) requires a municipality shall:

"prepare and adopt a budget including estimates of all sums required during the year for the purposes of the municipality, including,

(a) amounts sufficient to pay all debts of the municipality falling due within the year".

On November 2, 2022, Council received Staff Report FIN2022-029 2023 Capital Budget and discussed the list of capital projects presented.

On November 23, 2022, Council received Staff Report FIN2022-031 2023 Capital Budget and discussed the list of capital projects presented.

Staff Comments:

Staff have prepared a projected 2022 Capital and a draft 2023 Capital budget and 10 year forecast, detail is provided as Attachment 1. As discussed on November 23, 2022, changes made include the Collection Truck presentation update to reflect a 2024 delivery/payment and the increase in the requirement from taxation for Solid Waste smoothed to 2.8% a year for the next four years, and the Administration budget was updated to reduce the technology budget to \$6,000. In addition, the Road budget was updated to reflect to use of the 2023 sale proceeds that are to be contributed to reserve in 2024.

After the above changes, there remains insufficient funding available for all the projects to proceed. Staff request Council provide direction on which projects to proceed with.

The 2023 Budget (operating and capital consolidated) and the projected 2022 and the draft 2023 Budget Schedule of Reserve, Deferred Revenue and Reserve Funds will be provided at the next budget meeting.

Financial Implications:

Based on the 2022 Budget, each \$135,759 increase in the general taxation levy equates a 1% increase in the estimated blended tax rate.
