Title of Report: FIN2024-003 - 2024 Budget

#### **Recommendation:**

**Be it resolved that** Council receive Staff Report FIN2024-003 for information; and **That** Council direct staff to proceed with all necessary administrative actions.

### **Background:**

Municipal Act, 2001 s. 290(1) requires a municipality shall:

"prepare and adopt a budget including estimates of all sums required during the year for the purposes of the municipality, including,

(a) amounts sufficient to pay all debts of the municipality falling due within the year".

On November 15, 2023, Council passed the following resolution:

### **Financial Implications:**

Earlier adoption of the 2024 Budget would allow staff to tender any projects sooner. Past experience has shown better pricing from suppliers/vendors is generally obtained from earlier tender releases.

## **Concluding Comments:**

The draft 2024 Budget has a requirement from taxation of \$11,490,039, an increase of \$1,456,391 from the 2023 level. Staff has an estimate of a 1% increase in the blended tax rate of \$167,422 (2023 - \$150,753), including the approved 6.31% increase in the County tax rate and a no change in the Education Tax Rate. The increase of \$1,456,391 would result in approximately a 7.62% increase in the 2024 blended tax rate. Staff requested Council consider for approval the 2024 Budget on March 06, 2024.
