Recommendation:

Be it resolved that Council receive Staff Report PW2020-024 for information; and **That** That Council approves awarding the 2020 Hot Mix Paving Tender to The Murray Group Limited in the total amount of \$602,300.00 plus HST.

Background:

The 2020 Hot Mix Paving Tenders were opened on April 9, 2020 at 1:00 pm by Treasurer William Gott. The opening was done via electronic meeting software where other staff and the public attended virtually. Public Works Manager Jim Ellis and Public Works Foreman/Fleet Manager Phil Wilson reviewed the tenders that were submitted.

Staff Comments:

There were 2 bid submissions for the Hot Mix Paving tender. The MTO Performance Graded Asphalt Cement Price Index (PGACPI) specified in the tender release was based on averages of \$750.00. The following is the pricing submitted:

Financial Implications:

The 2020 Capital Budget for asphalt paving includes:

- 1. The asphalt paving on Wilders Lake Road from where existing pavement east of Varney stops to Southgate Sideroad 41 is a total of \$440,000.00 with \$25,000.00 funded through the Solar Reserve Fund, \$378,694.80 from Gas Tax Reserve, and \$36,305.20 from general taxation.
- 2. Southgate Road 22 from Southgate Sideroad 03 to SDR 07 is a total of \$325,000.00, with \$183,000.00 from the Ontario Community Infrastructure Fund and \$142,000.00 from general taxation.
- 3. Southgate Road 26 from Old Railroad to Homestead is a total of \$55,000.00 with \$35,000.00 being funded through developer contribution, and \$20,000 of reserves (carried over from the 2019 Capital Budget). The S31 culvert replacement has included asphalt pricing in that budget item.

4. The site plan agreement location is not reflected in the budget it will be funded through the property owner's agreement for cost recovery.
